The \_\_\_\_\_ subdivision submits this Letter of Intent to comply with the 2006 / 2018 (circle one) Park Land Dedication and Development Ordinance.

- This subdivision intends to dedicate a public park land and construct a public park in lieu of fees. We have met with the Parks Development Manager to review the requirements set forth in the ordinance and received preliminary approval to proceed with public park land dedication and development.
- This subdivision will pay the fees in-lieu-of park land dedication set at \$208 per dwelling unit and the required park development fees set at \$1,528 per dwelling unit and with no intent to construct a private park for credit. We will pay required fees when each plat is recorded.
- This subdivision will set aside land for a private park, as required by the ordinance, and intend to construct park improvements on the private park to be used as credit toward park land ordinance requirements. As fiscal surety, we will pay the in-lieu-of land and park development fees when each plat is recorded.
- This plat is a non-residential commercial subdivision and does not have park land requirements. However, if the zoning for this subdivision permits residential, at any time that residential dwelling units are added the owner/subdivider will contact the City and comply with ordinance requirements.
