a. This addendum incorporates the following questions:
1.Since the last RFP, the City has continued to grow its workforce due to the growth in the area. What is the total FTE count that is eligible for benefits? How many employees participate in the medical plan?
a. *We have roughly 645 benefit eligible employees, with approximately 556 enrolled in medical benefits.*
2.How many Medicare primary retirees and members are covered? How many non-Medicare (pre-65) retirees are covered?
a. *We have 27 Retirees that participate.*
3.What external firm, if any, provides benefit administration technology for annual and on-going enrollment? Is this firm directly contracted by the City or through the current broker/consultant firm/contract.
a. *Selerix is contracted through the City for enrollment.*
4.Does the RFP require annual GASB 75 valuation for OPEB liability? Is this service performed today by the incumbent broker? Or performed by another party?
a. *Not to our knowledge.*
5.Does the current broker/consulting firm earn any compensation through commissions paid by the medical TPA, stop-loss carrier or other insurance carriers?
a. *No.*
